

Before we get into the details, we'd like to thank all the delegates who have completed our feedback survey. We've had brilliant scores this year, once again, and great comments from attendees.

Astun news straight from the horse's mouth

Our user group always offers delegates the chance to learn about our development roadmap and see some of the latest geospatial innovations in action. This year was no exception with presentations from our MD and several of our technical experts.

Talks included an overview of Astun Data Services (ADS), including plans, such as the transition to Ordnance Survey APIs, from Matt Walker and Domna Kanari. Jo Cook and Elena Robu gave an overview of potential syndicated services for

of potential syndicated services for ADS, including national datasets of Electric Vehicle Charging Points, Energy Performance Certificates and a national Food Hygiene Ratings dataset.

Their talks were followed by an introduction to iShare Insights with Power BI, featuring ex-local authority GIS Manager David Renn and Elena. iShare Insights is an ideal way to enable users to access powerful data visualisations. Mike Saunt, our MD, introduced the concept of a My Councillor dashboard that could provide councillors with critical insights whilst raising their awareness of GIS. After all, local authority GIS teams can never have too many 'champions' within the management structure!

Call for Sites: going paperless

How interactive mapping and online applications save time, money and paper!

Introducing Call for Sites

Local authorities have a duty to maintain an adequate and upto-date supply of sites which are suitable for housing, employment and other types of development. A Call for Sites exercise provides a valuable early opportunity for interested parties to promote sites for consideration and helps to ensure that optimal development sites are considered and selected.

The need for paperless applications

The traditional Call for Sites process involves proposers submitting a paper application including a printed, annotated map (of various degrees of accuracy).

Submissions are often inconsistent and valuable time is taken up by scanning in applications and redrawing complex polygons onto an internal GIS.

The future of Call for Sites applications

Switching to an interactive map that's integrated with a GIS eliminates the need to manually plot user-supplied maps. Instead, proposers can capture a precise polygon extent against OS mapping which is loaded automatically into the system.

Keeping fingers on the pulse

As data is added to a GIS, planners and GIS officers can access a realtime view of submissions. Accurate site area measurements are calculated by the system, making it possible to easily determine when potential quotas are reached.

Benefits of a purely online application process

Making the switch to 'online-only' applications offers many benefits:

- A paperless solution is better for the environment
- Consistency: all proposals are accurately captured against the latest detailed Ordnance Survey mapping
- Users can view existing constraints on development
- Save time: no scanning is required
- Users are notified that their submission has been received
- Relevant information, such as green belts is easy to access



A focus on water positivity



AWS has committed to being water positive by 2030. That means returning more water to communities and the environment than it uses in direct operations, despite unprecedented droughts.

In 2022, AWS data centres improved their water use efficiency to 0.19 litres of water per kilowatt-hour (L/kWh). This was a 24% improvement from 2021.

Amazon as a whole made a \$10M planned contribution to help launch the Water.org Water & Climate Fund to directly empower one million people with water access by 2025, providing three billion litres of water per year in areas facing water scarcity.
